ANNUAL REGISTRATION

Membership is valid from 1st July 2010 to 30th June 2011.

PAYMENTS

In consideration of the certification by Thatcham of the Installer as a Thatcham Recognised Installer, the Installer shall pay Thatcham directly an annual fee of £200, which will include the fee for ten individual certificates, for which Thatcham shall subsequently send the Installer an invoice.

This annual fee is for the certification of the Installer for all, or a proportion of, the set twelve-month period upon which the Thatcham Recognised Installer programme runs and which is determined by Thatcham.

The Installer shall pay any unpaid invoice which is properly due and submitted to it by Thatcham, within 30 days of receipt, by credit card.

The Installer may purchase additional certificates from Thatcham by credit card in batches of ten, twenty-five or fifty certificates.

If the Installer fails to pay the amount due to Thatcham within 30 days of the date of the invoice, Thatcham shall be entitled to withdraw the certification of the Installer as a Thatcham Recognised Installer with immediate effect.

All fees are exclusive of VAT and are valid for the current twelve-month period.

INDEMNITY

The Thatcham Recognised Installer shall indemnify and hold Thatcham harmless from all claims and all direct, indirect or consequential liabilities (including loss of profits, loss of business, depletion of goodwill and similar losses), costs, proceedings, damages and expenses (including legal and other professional fees and expenses) awarded against, or incurred or paid by, Thatcham as a result of or in connection with the provision of the installation services by the Installer or the device or system that has been installed by the Installer.

The provisions of this indemnity shall survive termination of the Thatcham Recognised Installer status, for any reason.
